Import and Transport Honey Bees and used Beekeeping Equipment from within Canada to New Brunswick in 2023

AS PER SECTION 17(1) OF THE *BEE ACT*:

No person shall import bees or used beekeeping equipment into New Brunswick from another Canadian province or territory without an Import and Transport Permit.

Note: The importer (PERSON RESIDING IN NEW BRUNSWICK) must complete one application for each beekeeper supplying the bees.
