Payment of the application fee is required at the time of application and may be done by cash, cheque, money order, or credit card. DO NOT send cash or your credit card number by mail.</p> <p><b>Application Fee - \$41.69 (HST included)</b></p> <p><b>Payment method</b></p> <p>Check only one box.
