Owners of beneficial interests in the Global Debenture will not be entitled to have Debentures registered in their names, will not receive or be entitled to receive Debentures in definitive form and will not be considered holders thereof except in limited circumstances as described in the Global Debenture.

Principal and semi-annual interest (February 14 and August 14) on the Global Debenture will be payable in lawful money of Canada to the registered holder, CDS, with the first interest payment being for the period from February 14, 2020 to August 14, 2020. Owners of beneficial interests in the Global Debenture will receive payment in accordance with customary procedures of CDS.
