#### Introduction

The New Brunswick *Right to Information Act* was enacted in 1978 and proclaimed into force January 1, 1980. New Brunswick was the second jurisdiction in Canada to pass legislation giving a right to information concerning the public business of the Province to anyone wanting to know.

The *Act* was amended in 1979, 1982, 1985, 1986, 1995, 1998 and 2002. The 1995 amendment extended the scope of the *Act* to include the Hospital Corporation and school boards. Subsequently, the school boards as defined in the *Act* no longer exist. The 1998 amendments were a result of the introduction of Protection of Personal Information legislation.

The responsibility for the legislation lies with the Executive Council Office. The actual administration of the *Act* lies with each department, boards and agencies of government as listed under Schedule A of the regulation to respond to requests received by the Minister as prescribed by the *Act*.


In Spring 2007, a Right to Information and Protection of Personal Information Review Task Force was set up to review the Province's Right to Information and Protection of Personal Information Acts and make recommendation to enhance public access to government information while improving protection of personal information. The task force committee headed by Université de Moncton professor, Donald Savoie, also included Judy Wagner and Erik Denis of the Executive Council Office. After holding many consultation sessions over the summer months, the committee release its final report in September. Introduction of the new legislation is anticipated in Spring 2008.

In 2006-2007, the *Right to Information Act* web pages (French and English) of the on-line service directory were visited 6,703 times.


In June 2006, the 2<sup>nd</sup> annual Atlantic Canada Access and Privacy workshop was once again held in Halifax. 27 of the 112 delegates represented New Brunswick. Three of the 24 Speakers were from New Brunswick: Ian Walsh, Senior Policy Advisor presented on the Privacy, Access and Youth, Bernard Richard, Ombudsman and Child and Youth Advocate took part in the Plenary Panel for Review Officers and IP Commissioners and Chris Whalen, legal counsel for the Office of the Ombudsman and Child and Youth Advocate gave an overview of Canada's top ten privacy law cases of 2005-2006.

#### Number of Right to Information Act requests received by government since 1996

Government departments routinely make available information to the public. The *Right to Information Act* is used when information cannot be accessed through normal channels. In 2006-2007, 301 requests made under the *Act* were recorded.


# 2006-2007 Departmental Right to Information Act requests by applicant category

In 2006-2007, the difference in the number of requests by category in comparison to last year was notable in that requests from Members' of the Legislative Assembly decreased from 127 to **19**, consultants' from 60 to **29** and Law firms' from 54 to **34**, while public's increased to **93** from 64, media's to **63** from 50 and other organizations' to **63** from 44.


# Percentage of requests received by applicant category

In 2006-2007, the top user of the *Act* was the public with 31 per cent of the requests followed by the media and organizations with 21 per cent each. The remaining 27 per cent included requests from Members of the Legislative Assembly with 6 per cent, Consultants with 10 per cent and Law Firms with 11 per cent.



# **Disposition of Requests**

In 2006-2007, provincial government bodies, in processing requests under the *Act*, disclosed or partially disclosed information 68 per cent of the time; 19 per cent of requests were either withdrawn, referred or required clarification; while 13 per cent of the requests were denied.



#### **Application of the** *Act*

When provincial government bodies sever information from a document or withhold a document, they must indicate which section of the *Act* authorizes the decision. The bar graph below indicates the number of times that a section was cited in responding to requests. Because more than one section may be cited in response to a single request, the number of occurrences does not coincide with the total number of requests recorded for this fiscal year.

The table below provides a breakdown for the number of times a public body cited a section in response to requests.



# **Processing Times**

Under the New Brunswick's access legislation, a request must be responded to within 30 days of the date it was received by the Minister. The *Act* does not allow for any extensions. For 2006-2007, 65 % of the requests received were completed within 30-day timeframe while 33% required more time to respond. The remaining 2% accounts for requests that were withdrawn.

An applicant, who is not satisfied with the Minister's response or where a Minister has failed to reply within the prescribed timeframe of 30 days, may refer the matter to the Ombudsman or the Court of Queen's Bench for review. In 2006 - 2007, all reviews under the *Act* were petitions to the Ombudsman.
