○ 4.1 Executive Director's report

 B. Lyons provided a summary of work accomplished and ongoing since the February 2017 meeting.

4.2 Presentation from Accueil Sainte-Famille

Presentation given by Nadia Losier, Director.

○ 4.3 Annual Work Plan

• Consensus to adopt annual work plan with changes (remove reference to working on party platforms for the 2018 election; add developing and issuing a gender equality and/or women's platform for the 2018 election). Additional decisions: council co-chairs and executive director may meet with individuals or groups (including Members of the Legislative assembly and their staff, as well as other political party staffers) to discuss the platform the council releases; the council will not do analysis of party platforms and will simply reiterate its own platform; further decisions to be made regarding format of a leaders forum/debate on gender equality/women's equality issues for the 2018 election. ACTION: B. Lyons to update document and recirculate.

o 4.4 Violence in the Workplace

• E. Whitmore shared information from meeting with NB Nurses Union in March. Consensus to support adding violence in the workplace to New Brunswick's *Occupational Health and Safety Act.* **ACTION:** B. Lyons and E. Whitmore to identify and further research occupations that are predominately staffed by women and present an elevated risk of violence.

○ 4.5 Sexual Violence

J. Richard presented "Preventing and Responding to Sexual Violence in New Brunswick: A
Framework for Action." Consensus that the council would support the framework if it is publicly
released and is similar to current version and advise that next steps focus on resourcing and
timelines. ACTION: If the framework is publicly released, staff and co-chairs to consult with the
Fredericton Sexual Assault Centre before responding.

council is not opposed in principle to participating in government media releases and entrusts
the staff team with decision-making on such opportunities.
